You may begin signing in for the meeting at 5:45 P.M. It is recommended that you sign-in early so the meeting may begin promptly. Please sign and return the Proxy/Absentee Ballot no later than Thursday, 8/21/2025 at 12:00 P.M. You may mail or email your signed forms or complete the digital voting and proxy on TownSq. It is very important that you assign your Proxy, even if you plan on attending, as a last-minute event might prevent you from attending the day of the meeting. If you do attend the meeting, your Proxy will not be used. Please reference Proxy information and instructions on the Proxy/Absentee Ballot form.

IMPORTANT INFORMATION ABOUT VOTING ON PROPOSED AMENDMENTS



All homeowners need to be aware of upcoming voting being held at the annual meeting on proposed amendments to the Northpointe Crossing governing documents. We need to hear your voice! At this time, changes made to the governing documents for your HOA, there must be a vote of 67% homeowners approving those changes. That's almost 500 homes!

IT IS IMPERATIVE THAT YOU TAKE ACTION ON VOTING IF YOU SUPPORT ONE OF THESE AMENDMENTS

Please be on the lookout for the following coming your way:

- 1. Information on the Annual Election Call for Candidates and Voting Process
- 2. Information on Amendment to your CC&R guidelines:
 - 1. Amendment 1: Change the tree requirement from 2 trees being required to 1 tree being required
 - 2. Amendment 2: Change the voting percentage for CC&R amendment, from 67% to 50% +1
 - 3. **Amendment 3:** Vote for the addition of a rental/leasing policy
 - Cap rentals at no more than 15% of lots in the association
 - Lot must be owner occupied for 1 year before conversion to a rental
 - Lot rental agreements may not be less than 3 months in term
 - Grandfather clause regulation included

As you can see, there is very high percentage needed to make the proposed changes to your governing documents. All votes will take place at the Northpointe Crossing Annual Meeting. The board has worked hard to make the voting process as easy as possible and allow for online electronic voting which is slated to begin on Friday, August 8th at 12:00 p.m. As the voting timeline is opened, stay diligent about the deadline so your vote will count!
