WHEREAS, after careful review, the Board has determined that the Program is no longer necessary or effective in achieving its intended goals;

WHEREAS, the Board has received feedback from membership, including property owners and board members, and has reviewed the costs, challenges, and redundancy of the Program in light of existing local, state, and federal regulations governing rental properties;

WHEREAS, it is in the best interests of the Association rescind the Program and eliminate the associated requirements;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Association as follows:
1. Rescission of the Program: Established by Resolution, is hereby rescinded in its entirety,
effectiveApril 3rd, 2025
2. Cease Enforcement: The Board of Directors hereby directs the management group to
immediately suspend all enforcement activities related to the Program. This includes, but is not
limited to, the cessation of registration requirements, fee collection, penalty enforcement, and
inspections. Furthermore, the management group is instructed to provide full refunds to all owners
who have previously paid fees under the Program.
3. Notification: The Board directs that notice of the rescission of the Program be provided to all
registered property owners a membership, and that this notice be published on the Association's
website and in local communications.
